14(a) – New Constitution

Legal advice is that although there is minimal risk of exposure it is prudent for OSF to consider incorporation to ensure Officers are covered for any liability that may arise. It is not recommended that OSF become an entity under the Company's Act. Several other Oceania Sports Federations are undergoing this process and discussion has been undertaken with several of these entities as to their approach. Queensland State Legislation has been amended recently and Oceania Federations are able to incorporate under the new legislation under the *Fair Trades Act*.

7. OSF CHAMPIONSHIPS REPORTS

7.1 2011 Pacific Games, Noumea (David Boyd)

- squash is included in program as official sport, to include teams, singles and doubles
- optimistic about squash competition and hope countries will commit to sending teams
- 6 countries expected to confirm, with possible 2 additional countries participating (Vanuatu and Tahiti)
- although Solomon Islands have 2 courts they are not active and not expected to compete.
- additional 2 courts being built in Noumea will have 5 singles and 1 doubles court

7.2 2009 Pacific Mini Games (Robert Skews)

- all preparations have gone smoothly thanks to CI Organising Committee
- looking forward to a friendly and competitive games
- CI enquired as to be reasons of NI withdrawal from 2009 PMG
- current PG eligibility rules excludes many NI players and decision made to boycott games
- NI have committed to compete at the 2011 Games.

7.3 <u>2013 Oceania Championships</u>

- No squash in 2013 Mini Games as games are being held in Wallis & Futuna
- Request for Expressions of Interest to host the 2013 Oceania Championships to be circulated in October/November. NI already lodged EOI.
- recommendation to appoint hosting country to be circulated to countries for comment prior to decision of OSF Officers

7.4 <u>Oceania Masters Championships</u>

- Report on NI 2008 15th Oceania Masters Championships tabled. Moved Mousie Skews (CI), 2nd Butch Gifford (NZ) that the report be accepted. CARRIED
- 2009 16th Championships will be held in Whakatane, NZ in October. Planning is well underway. Butch Gifford will be the OSF representative.
- 2010 17th Oceania Masters Championships will be hosted by Samoa utilizing the new facilities built for the 2007 Pacific Games.
- Request for Expressions of Interest to host the 2011 Championships to be circulated. NI already lodged EOI.

7.5 Oceania Junior Championships

- members are keen to reinstate the Oceania Junior Championships
- rules and playing arrangements to be reviewed and age groups changed to U13, 15,17,19
- as Fiji already have sponsor committed they will be offered opportunity to host the 2010 Junior Championships (subject to current political situation in Fiji)
- need to coordinate dates to maximize opportunity for AUS and NZ players to compete

7.6 Oceania Open

- members keen to reinstate the Oceania Open Championships
- request for Expressions of Interest to host the 2010 Oceania Open to be circulated
- preference will be for hosting country to commit to 2 or 3 year hosting package

7.7 Pacific Circuit

- important to attempt to have all Oceania Championships included in a Pacific Circuit so as to encourage the maximum number of Oceania & international players to support events
- Competitions Committee to coordinate Tournament Calendar to avoid clashes

8. Major Games Reports

- 8.1 Olympic Games Bid
 - squash was not included in the recommended sports for 2016 Olympics
- 8.2 <u>Commonwealth Games</u>
 - Australia, New Zealand, Cook Islands, PNG, Norfolk Island and Samoa eligible to compete. (Fiji currently suspended)
 - Australia, New Zealand and PNG confirmed nomination of athletes in squash program
- 8.3 2009 <u>Arafura Games</u> (Carol Kawaljenko)
 - verbal report on the 2009 given, written report to be circulated
 - NC commended on its success at the Games.

9. ONOC and OSFO Report

- P/ED represented OSF at meeting held in Queenstown, NZ in April 2009.
- A presentation from cities and 6 of 7 sports bidding for the 2 available sport positions were presented to participants.
- Main focus of workshop was Player Eligibility for Pacific Games and PG Charter
- Oceania Sports Federation concerned that Games cannot be used as a qualifying event for Olympics as the Playing Rules & Regulations are not consistent with sport's international eligibility rules
- Pacific Games Council advised that current ruling will prevail, but may be reviewed in future

10. General Business

10.1 Notice of Motion from New Zealand Squash regarding Governance Issues of OSF

- paper intended to initiate review, not implementation at 2009 General Meeting \boldsymbol{Motion} — that issues outlined in paper be considered in review of OSF Governance. Moved Butch Gifford (NZ), 2^{nd} Norman Wetzell (SAM). CARRIED

10.2 <u>Strategic Planning and Outcomes of Conference/Workshop</u>

- Proposed 2010-2015 Strategic Plan to be reviewed in final workshop session.
- as the Conference/Workshop had not concluded prior to the commencement of the General Meeting outcomes are to be considered once all sessions are concluded.

10.3 Life Membership

- criteria for Life Membership discussed.

Motion – that a criteria for Life Membership of the Oceania Squash Federation be implemented to assist in future consideration of submissions from members. Moved Carol Kawaljenko (AUS), 2nd Robert Skews (CI). CARRIED

10.4 <u>Member Voting Rights</u>

- clarification of when voting rights are implemented requested
- P/ED advised that for normal issues each member has only 1 vote
- voting rights (as outlined at the commencement of the meeting) were only evoked when decisions on major issues were under consideration, eg budget, constitutional reviews etc.

10.5 Marketing

- OSFO have requested any photos from 2005 and 2007 games
- any member able to provide photos is asked to forward to P/ED

10.6 Phillip Cridge Trophy

- only 5 replica trophies were made originally and they have been used
- PNG approached to source additional replica trophies
- Paul Speedy & Derek Hunter have provided additional replicas free of charge as Steel Industries have agreed to donate in remembrance of Phillip's input into PNG squash.
- P/ED to forward Certificate of Appreciation
