CK. Re monies owing. CC advised there is only a small amount outstanding from PNG.

GD. Are these transactions regular?

CC. Yes with upsurge before major Championships. Can be extra costs such as sending Regional VP to Rotterdam for WSF AGM.

GD. Interest only \$8.90 and could get 6.5% easily e.g. ING - could be worth up to \$650/year.

CK. Electronic banking is needed.

CC. Typos. Under <u>\$AUD Proposed</u>, change 11.100 to 11,100 and 12.200 to 12,200.

# Financial position of OSF

CC. Position of Secretary-General (now Executive Officer) decided yesterday.

CC. Position of Development Officer (DO) will be a major expense item to be explored by new Officers.

NZ's CEO strongly supports the position of DO to move around islands. He advised that table tennis has had great success doing this.

ES. Samoa fully supports the idea and wants it to happen quickly, but OSF needs to:

- 1. Set up a development template, and
- 2. Ensure DO spends an appropriate time at each place to make it worthwhile, and
- 3. DO must be in constant contact as follow-up, and
- 4. Local Associations must appoint a person to work with the DO and continue the work, and
- 5. Funding should be sought from the wider Oceania corporate area with the right approach most important e.g. ANZ Bank, Westpac, and this to be acknowledged by all Associations in their letterheads, etc to give mileage for sponsors.

As this DO moves around islands, information and solutions can be shared.

BG. Need to carefully work with all stakeholders.

CC. Due to Olympic bid, squash needs to have close relationship with other sports. Corporate sponsorship needed. Been openly critical of WSF in this area. Should make this a high priority.

CC. Need to recognise Australia and NZ are main financial contributors and will continue to be.

# Proposed Budget / Setting of Fees

CC. Used 2-year increments due to major Championships incurring heavier expenditure.

CK. Questioned if a formula was used for setting of fees cf court numbers.

CC. Yes, but particularly looking after Vanuatu in their initial stage.

Moved ES, seconded CK that Budget be accepted.

- Number of Plate events to be reviewed. CS. Trophy cost of \$1360 could then be reduced.
- PG Council want to move towards having local people run all areas of the sports and funding assistance may be cut for referees and tournament organisers.
  - CS. Whilst not ideal, confident that if necessary currently accredited Oceania referees can handle the refereeing at events. This won't allow for assessments for new and existing referees.

MT. 19<sup>th</sup> Oceania Masters will be held Cook Islands May 21-25, 2012.

Ranking list for juniors been introduced by <u>WSF</u>. New Committee will contact Members re this. Conscious of protecting the interest of Oceania's juniors.

2011 Oceania Open was deferred due to lack of courts available in PNG. Will be reviewed depending on construction of new facilities.

The <u>Pacific circuit</u> needs to be discussed by the new Committee.

- Bid process is underway for 2020 Olympics.
- <u>2018 Commonwealth Games</u> Gold Coast has a bid in with result to be known within 2 weeks. [result in-awarded to Gold Coast].
- <u>2015 Commonwealth Youth Games</u> will be held in Samoa. Eight sports have been approved, including Squash. Open to all under 18 years, but exact age eligibility to be advised by Etuale.

# Dispute Resolution

CC Presented a Paper on this as requested.

GD. Cannot deprive a person of the right to appeal to a court. Ideally best step is to handle internally and must ensure members use internal procedure first then go to legal step.

DB. Gave examples from Squash Australia showing the importance of having correct procedures in place.

ES and CK. Suggested Constitution should refer to OSF's Dispute Resolution procedure/Regulation, to avoid changing Constitution.

CC. Asked GD to handle this issue and report back to the Executive Officer.

BG. If there is a potential cost for OSF to go to court, OSF may wish to consider Incorporating in NZ where there is no cost.

<u>Decision</u>: Constitution to say (1) should be settled internally first. (2) to be settled in accordance with Regulation xxx.

## **OSF CONSTITUTION**

Original 1992. Some amendments 1996.

Document had been widely distributed for comments.

## Issues discussed - in brief

### <u>Incorporation</u>

What jurisdiction does Incorporation in e.g. an Australian State have over an OSF country? Incorporation is to protect the Members so Incorporation serves OSF.

#### **Appeals**

Re expelling a country. Expensive to bring countries together.

Level of Appeals. Who does a country appeal to if still disagree with an OSF decisions.

Always have right to appeal to WSF.

Must add an area re Dispute Resolution.

Col to look at overnight

## **Officers**

Awareness of having too small a Committee. If all change, experience lost.

#### Life Members

Immediate Past President (IPP) to have an Officer's position with voting rights.

## Quorum to be 4

## **Auditor**

Officers to appoint within 30 days. Books to be audited only for Annual General Meetings.

Secretary-General terminology. Changed to Executive Officer

Cut out a lot of the unnecessary things listed as job description.

Decision: The EO is responsible for the day-to-day running of the Association.

## Committee to comprise 5

1 President

2 Vice Presidents

1 Immediate Past President

1 Executive Officer

Confirmation if votes are tied, vote is lost

Col as President has always used his casting vote to vote against

# Rotation of Officers

For continuity 2 will rotate in alternate years.

2012 President and 1 VP

2013 Other VP and EO

Consideration of allowing for opportunities for others to come onto Committee

Officers can serve only 2 consecutive terms in same position

Officers not eligible to stand again for same position until a 2 year absence

Proxies to be in writing

#### Meetings

Need more countries at meetings.

Annual meetings must be retained

More flexibility needed. Should be held with Pacific Games in alternate years.

Other years elsewhere but expense discussed.

Representatives must commit to meeting, not to being manager/player. However countries cannot afford to send someone just for a meeting.

## OSF Regional Representative to WSF

Meeting felt OSF has not been appropriately represented at WSF level. For financial reasons Australia/NZ have represented as they can afford to attend. But OSF President/ED has had to do all the work for this person.

Decision: OSF President will be representative at WSF – realising finances need to be considered.

## OCEANIA CHAMPIONSHIPS

Next Oceania Championships due Norfolk island. MT asked to submit 3 alternate dates based on flights and accommodation, and present to Members. Likely to be October.

## Oceania Junior and Youth

Unlike other WSF Regions, OSF does not have OSF Junior Championships. Needed for the development of the sport.

WSF now has ranking system for Juniors and OSF's juniors will be disadvantaged

Countries need a solid junior base with a committed person to run them in each country. ICC (cricket) had great success sending someone into Samoa.

Squash will never replace major sports. Must work with them.

Development Officer to be discussed at GM.

## Scheduling

Encourage working in with Australia and NZ's major events. Calendars almost ready.

Members should give early notice of their Opens.

# No squash in next $\boldsymbol{Mini\ Games}$ in Wallis and Futuna

Oceania Championships not bound by Pacific Charter. Can make own decisions but best to try and work in where appropriate.

Hopefully squash will be in PNG, but 4 sports will be knocked out. Squash borderline with 6 competing countries and is classified as being a non-progressive sport due to lack of new member countries taking up the sport.

PNG Sports Federation should be pushing for squash noting their medal prospects and have a very good junior player.

- 2012 Oceania Masters Cook Islands May 21 25
- 2013 Oceania Championships Norfolk Island date to be set
- 2013 Oceania Masters Venue to be set
- 2015 Pacific Games PNG Subject to squash being selected as a participating sport. If selected, the new courts will have to be built. Not sure then if courts can be constructed in time.
- 2017 Mini Games in Vanuatu. Not a selected sport at this stage but being negotiated with Games Authority. Otherwise, it will be a stand-alone Oceania Championships at a venue to be determined

## PRESENTATION BY SQUASH AUSTRALIA. Gary O'Donnell. CEO

2018 CWG bid for Gold Coast (with Sri Lanka). DVD shown Squash will be at Runaway Bay

Looked into funding e.g. Pacific Sport Development and Grants Program and information distributed.

## FORMAT OF FUTURE OCEANIA EVENTS

Countries don't all have Doubles courts. Looking into playing Doubles on Singles courts. Could be a problem with Insurance. Shortage of Ladies teams. Discussed reducing Ladies teams from 5 players to 4 (3 + Reserve).

Countries currently send 10 players (4 players + reserve for each Men's and Ladies).

Discussed Teams of 3.

Discussed Pools.

3 in a Team aligns with WSF's World teams.

Need to reduce length of events. Too expensive. It cost Samoa A\$20,000 to send their teams to New Caledonia.

Proposed format to be reworked and submitted to Officers

## Decisions:

- Countries to send Teams of 5 comprising 3 players and 2 reserves (not 4/1)
- Play 3 to a Team
- Singles. One Plate
- Teams. Round Robin
- Doubles. No Plate
- Events (Individuals, Doubles and Teams) to run concurrently where possible
- All changes will apply to OC in NI
- Keep in mind allowing opportunities for new, young players to get into the Teams.

# **Pacific Cup**

Excludes Australia and New Zealand. Eligibility rules are complex. Including A and NZ could help with sponsorship. Recommendation:

Ask A and NZ. (1) Would they participate? (2) What standard players would they be likely to send? (not top level players hopefully)

Then send to Member Nations
